Learning at Home Television Resources

DCPS Early Literacy

In partnership with DCTV and the DC Office of Cable Television, Film, Music & Entertainment (OCTFME), DCPS is expanding on its commitment to keep learning accessible for all students during this period of learning at home.

Early literacy video lessons air each weekday on the District Knowledge Network (DKN) at 9:00 am (Kindergarten), 9:30 am (1st Grade), and 10:00 am (2nd Grade) and feature DCPS teachers leading the same instruction students receive in school. Lessons will be rebroadcast each afternoon from 1:00 to 2:30 pm. Catch DKN on cable via the following channels: Comcast (channel 99), RCN (channel 18), and Verizon (channel 12), as well as the <u>DKN Live Stream</u>.

Beginning on Monday, April 6, the "Kindergarten Hour" will expand to include Kindergarten lessons in English at 9:00 am, Kindergarten lessons in Spanish at 9:30 am, and then will be followed by the 1st grade lesson at 10:00 am and 2nd grade at 10:30 am.

WTU "Learning Doesn't Stop" Lessons

The WTU is partnering with Fox5, its sister station, FoxPlus WDCA-TV, and ABC to air lessons on television for students during school closures. The lessons, presented by District of Columbia Public Schools teachers, will air each weekday at 10:00 a.m. Each day of the week will feature a 30-minute lesson aligned with district learning standards for a particular grade group. Teachers also will post the lessons on WTU's website, <u>www.wtulocal6.net</u>, so students and their families can work on the lessons discussed throughout the week. Stay at Home Guidance for Essential Employees

Mayor Muriel Bowser issued a <u>stay-at-home order</u> for the District of Columbia in an effort to reduce the increasing number of coronavirus (COVID-19) cases in our region.

<u>Under the new order which took effect on Wednesday, April 1, 2020 at 12:01 am, District residents</u> should only leave their homes for the following reasons:

- to engage in essential activities, including obtaining medical care that cannot be provided through telehealth and obtaining food and essential household goods;
- to perform or access essential governmental functions;
- to work at essential businesses;
- to engage in essential travel; or
- to engage in allowable recreational activities, as defined by the Mayor's Order.

All DC Government employees (essential and non-essential) are required to adhere to this lawful measure. Should you be stopped by law enforcement on your way to or from work, please display your District government identification card and driver's license. Employees who are residents of Maryland and Virginia, please note that they have also issued a stay-at-home order, please review their guidelines.

DOL FMLA Guidance

The Families First Coronavirus Response Act (FFCRA) requires certain employers to provide employees with paid sick leave or expanded family and medical leave for specified reasons related to COVID-19. The Department of Labor's Wage and Hour Division administers and enforces the new law's paid leave requirements. The temporary rule is effective from April 1, 2020 through December 31, 2020.
