Purpose of the Disposition & Lease Extension Public Meeting

- Purpose of tonight's hearing is to receive **community comments on the proposed extension of the lease disposition** of the Gibbs School, located at 500 19th Street NE.
- Designating a property as "disposed" means that the **government no longer requires the property for District-operated public uses**, including DCPS schools, fire stations, police stations, and District agency office space, etc.
- In 2015, DGS and the Charter School Incubator Initiative entered into a 20-year lease agreement. This lease expires in 2035.
- In 2021, the Mayor introduced the **Gibbs School Disposition Extension Act of 2021.** This would authorize the Mayor to extend, by more than 20 years, the term of an existing lease agreement of District-owned real property located at 500 19th Street. NE.
- The legislation would provide an amended initial term of twenty-five (25) years (i.e., an extension from 2035 to 2046) and one (1) option to extend the initial term for a twenty-five (25) year period from the time lease amendment is executed.
- Tonight's public meeting on the disposition and lease extension allows us to gather community feedback on the proposed lease extension.





Site Background and Intended Purpose

- The Gibbs building is located at 500 19th Street NE (see map).
- Gibbs School was closed at the end of SY2007-08 and last served grades PK3 to 6th with approximately 280 students.
- In 2014, the Deputy Mayor for Education, on behalf of the Mayor, issued a request for offer (RFO) for the surplus and disposition designation of the Property. The Charter School Incubator Initiative was awarded a ground lease for a 20-year term. The lease was executed on June 17, 2015.
- Since 2015, Monument Academy Public Charter School has occupied the Gibbs School.
- Per the **Gibbs School Disposition Extension Act of 2021**, the District proposes to approve the extension of the disposition of District-owned real property located at 500 19th Street, NE.
