Closed DCPS Facilities - Current Status August 2019


70 former DCPS facilities remain in educational use or are government-owned.

- 39 former DCPS facilities (56%) are currently home to public charter schools, either owned or leased.
 - 55% (34/62) of all public charter LEAs operate in a former DCPS facility.
- 5 facilities are still in use by DCPS
- 16 facilities are in active use by other DC agencies.
- 7 facilities are either leased to other entities or are under economic development.
- 3 facilities are vacant and undergoing DCPS programmatic review.
 - 385,000 gross square feet across the 3 facilities.





Closed DCPS Facilities - Educational or Government-Owned



39 Former DCPS Facilities Home to Public Charter Schools

- 39 former DCPS facilities are home to public charter schools, either owned or leased.
 - 55% (34/62) of all public charter LEAs are currently in a former DCPS or Districtowned building.
